POLICY COVERAGE*

Limit of Liability : As per Premium Table (any one claim and in the aggregate)

instructing or supervising your students, and should an action or proceeding be filed against you, you may be legally obligated to pay any monetary damages, judgments, settlements and/or third party legal costs. In addition, you may incur

significant expenses in the defence of such a claim.

All defence expenses incurred by you and costs that you are legally obligated to pay in a civil, criminal, administrative, regulatory or arbitration proceeding against you will be indemnified up to the limit of liability, as long as it is first made against you and

notified to us during the period of insurance or discovery period.
